

2023 PROPERTYPAL AWARDS

TERMS AND CONDITIONS



DEFINITIONS

In the Terms & Conditions of Award Entry, the following definitions apply:

'The Event' or 'Awards' means *The PropertyPal Awards 2023*

'Judge' means Award Judge / 'Winner' means Award Winner / 'Finalist' means Award Finalist / 'Entrant' means Award Entrant

'Attendee' means any person or business attending or registering to attend *The PropertyPal Awards 2023*

'Venue' is Titanic Belfast, Northern Ireland.

1. The PropertyPal Awards are organised by PropertyPal of Unit 2D, Jennymount Business Park, N Derby St, Belfast, BT15 3HN.
2. By entering The PropertyPal Awards, participants will be deemed to have accepted and be bound by the Terms and Conditions. All entry instructions form part of these Terms and Conditions.
3. By entering the competition, you must agree to disclose your details (name and email address and in some cases contact number) for the purpose of being contacted if you are shortlisted.
4. By entering The PropertyPal Awards, all award and category entrants have agreed to allow the details of their entry to be shared with the judges and representatives of PropertyPal. All entrants will be deemed to have consented to the transfer and sharing of their personal, company and project data and information for the purpose of administration and judging of the awards and any other purposes to which the entrant has consented including digital and print marketing.
5. The awards are open to Northern Ireland Estate Agents, Developers, Marketing Agencies, PropTech companies, Lawyers, Surveyors and Construction Professionals aged 18 years and over. Each category provides more information on the relevant entrants.
6. Submissions open on **12th June 2023** and close on **31st July 2023 at 6pm**.
7. Employees of PropertyPal and their families are excluded from the awards.
8. All category entries must be received by PropertyPal prior to the submission deadline. Entries received after the submission deadline will not be accepted. Neither PropertyPal nor the judges will not accept responsibility or liability for any lost, late, mislaid or incomplete entries with all such entries deemed invalid. For the purpose of doubt, proof of dispatch shall not be accepted as proof of entry.
9. All category entries must be submitted in English and submitted electronically with supporting documents (if applicable) using the Entry form. Any entry received by any other means including via email, fax, post or hand-delivered will not be accepted.
10. Upon written request, entries may be withdrawn by the entrant prior to **31st July 2023**.
11. All entrants must be aged 18 or over. The entrant or the employer represented by the entrant must have worked or be directly associated with the business, project or solution that is featured in the entry.
12. Entries must be submitted and paid by the person with whom all future correspondence about the awards and finalist information will be sent.
13. Entrants may enter multiple award categories, however, all submitted entries must be tailored for each individual category.
14. All category finalists will be notified via email on **15th August 2023**. Entries that have not been shortlisted will not be notified via email or other correspondence.
15. Award winners will be announced during the awards dinner taking place in the Titanic Belfast on Thursday 16th November 2023. Under no circumstances will the details of winners be disclosed prior to the event. During the awards dinner, one award winner and one runner-up will be announced from the finalists in each award with award winners receiving trophies at the event.
16. Category winners, runners-up and finalists are not

- provided with complimentary tickets to the awards dinner.
17. The judges and PropertyPal reserve the right to amend category selections where it is deemed appropriate.
 18. The judges reserve the right to disqualify any entry not accompanied by the appropriate/correct supporting documentation or any entry deemed to be inaccurate, false or misleading.
 19. The judges and PropertyPal accept no responsibility for any costs associated with entering or attending the awards. This includes but is not limited to: Attending the awards dinner or the creation, submission, judging and/or evaluation of award entries.
 20. PropertyPal will not be held responsible for any travel, accommodation and/or (non-event served) food or refreshment requirements of an award attendee, finalist or winner.
 21. PropertyPal reserves the right at its own discretion to alter or reschedule the awards, the awards dinner and/or to change the judging panel and/or these terms at any time and without notice.
 22. Should the event be rescheduled, these terms remain binding between PropertyPal and all award entrants and dinner attendees for a period of 6 months from the originally scheduled date of the awards dinner. Should the awards dinner be rescheduled, the awards dinner will be held within 6 months of the date of the originally scheduled dinner and in the case that an attendee is unable to attend the rescheduled event, a substitute attendee may be nominated up to 7 days prior to the rescheduled awards dinner without charge. Should the awards dinner be cancelled or not rescheduled or held within 6 months of the originally scheduled dinner, a refund limited to the sum of a fully paid table or individual ticket cost which has been paid by an entrant or attendee will be offered. For the purpose of doubt, a change of name, a rescheduled date within 6 months of the original scheduled awards dinner or relocation of the awards dinner is not a cancellation.
 23. PropertyPal will not be liable for any death, injury, financial loss or damage sustained by an award attendee as a result of, or arising from any circumstances, including but not limited to financial losses arising from the rescheduling or the cancellation of the awards or awards dinner by PropertyPal, which right PropertyPal hereby reserves where in its opinion it thinks such action necessary, or appropriate under such circumstances which are deemed to be outside the control of PropertyPal. For the purposes of this agreement, non-exhaustive illustrations of those matters which are hereby agreed to be outside PropertyPal's reasonable control include fire, storm, tempest, lightning, other abnormal weather conditions, national emergency, labour disputes, strikes, lockouts, civil disturbances, explosion, inevitable accident, threatened or actual war, armed conflict, terrorist attack or nuclear, chemical or biological contamination or the withdrawal or non-appearance of key presenters of the awards dinner. Should PropertyPal cancel the awards dinner, this agreement shall automatically terminate.
 24. PropertyPal will not be held responsible for the security of any award attendee nor for any attendee's personal belongings. All award attendees accept and acknowledge that neither PropertyPal nor the venue maintains insurance covering any attendee's property and/or liability, and it is the sole responsibility of the award attendee to obtain such insurance.
 25. All award entrants and award attendees agree to indemnify PropertyPal against all costs, claims, damages and expenses that any award entrant and/or award attendee incurs as a result of, or in connection with; any breach of this agreement by PropertyPal; or any complaint or claim made or brought against PropertyPal in respect of any act or omission on the part of any award entrant, its representatives, award dinner guests or any award attendee.
 26. During the award dinner, alcoholic beverages will be served for the enjoyment of attendees. PropertyPal strongly advises all award attendees to keep within the Northern Ireland legal drink driving alcohol limits. By agreeing to these terms & conditions, all award attendees accept full responsibility for their own actions and acknowledge and agree that PropertyPal, the event suppliers, the venue and event sponsors will not be held responsible for any attendees' actions following the consumption of alcohol, or from any related or non-related circumstance which may occur prior, during or following the awards dinner.
 27. While peanuts or other tree nuts may not be an ingredient in the food served at the awards dinner, menu items may be produced in the same area as food containing various nuts. PropertyPal,

- the event caters, the suppliers and the venue wish to advise sufferers of nut allergies, that although best practices are used in the preparation of food served by the venue, inadvertent cross-contamination of nuts and nut traces may occur.
